Coming from care these young people lack confidence and have usually failed at school, not because they are unintelligent, but because the lack of normal family love and guidance has affected them badly.

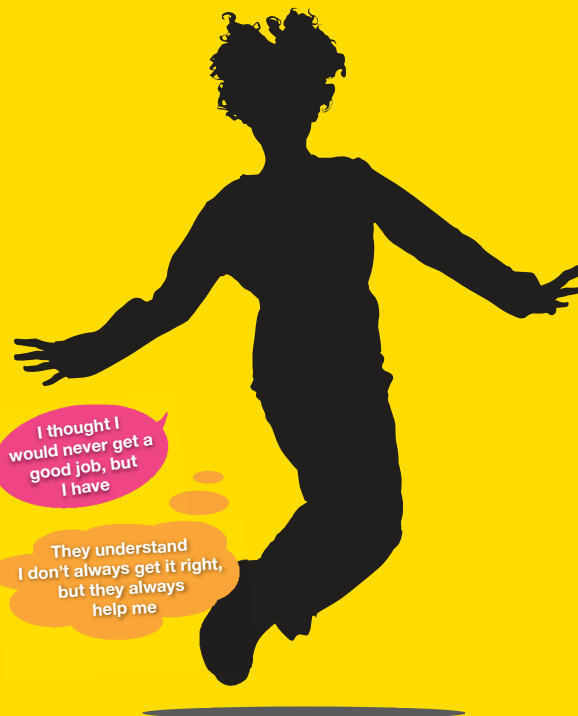
We give the help the state cannot afford to give.

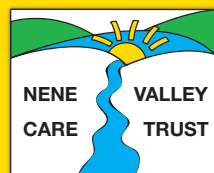

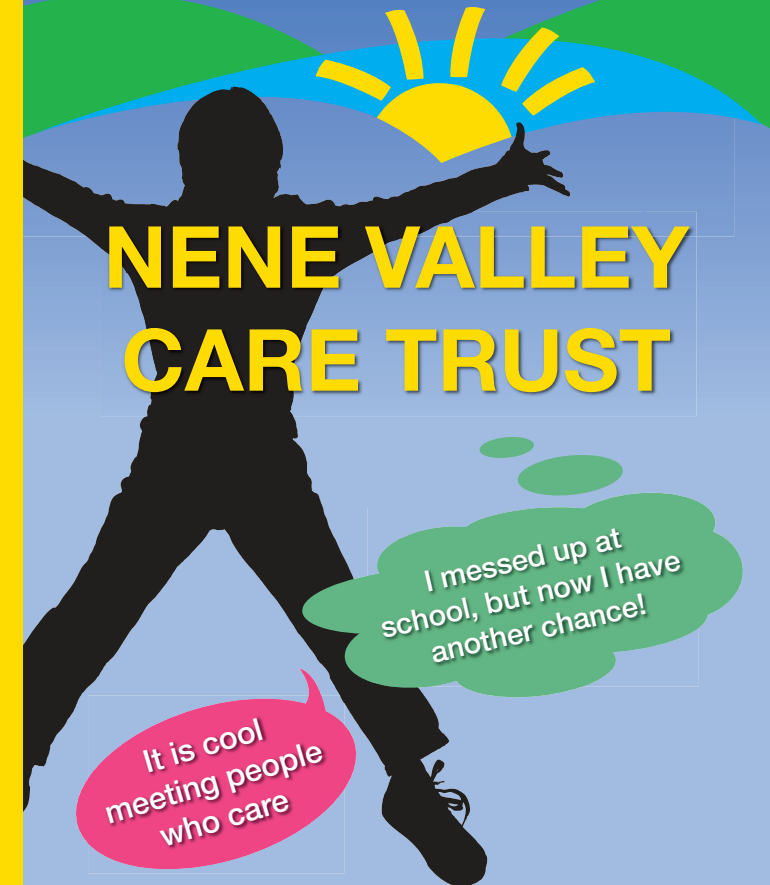
